# The Division of Workforce Development and Adult Learning (DWDAL)

DWDAL coordinates job seeker services and training, business services, adult learning programs, and labor market information. DWDAL's goal is to ensure that businesses have skilled workers and job seekers have access to employment and training resources and services. The programs include:

UI administers the collection of unemployment taxes, the determination of employer rates, and the payment of benefits to eligible individuals. The Division also provides connections and resources to support claimants through benefits and workforce development opportunities for re-employment.

O&P supports the licensing process for 21 licensing boards and commissions, and four licensing programs. These boards and programs regulate the activities of more than 255,000 individuals and businesses across 25 professions.

O&P oversees licensing systems by qualifying and testing individuals for licensing; issuing and renewing licenses; establishing standards of practice for the occupation or profession, including ethical standards; and enforcing licensees' compliance with practice standards and Maryland law.

OFR licenses, registers, charters, and supervises financial institutions and other businesses that provide financial services to Maryland consumers. The Division of Family and Medical Leave Insurance (FAMLI) is a new and growing team within the Maryland Department of Labor. The FAMLI Division was established to administer Maryland's paid family and medical leave insurance system, which will be funded by contributions from employers and workers.

FAMLI will ensure that, starting in 2026, workers in Maryland have access to paid leave when they need to be away from work to care for themselves or a family member.
