## REQUIREMENTS FOR RETIRED STATUS LICENSE

(A) THE BOARD MAY ISSUE A RETIRED STATUS LICENSE TO AN INDIVIDUAL WHO: IS CURRENTLY LICENSED IN MARYLAND AS A PROFESSIONAL LAND (1)SURVEYOR OR A PROPERTY LINE SURVEYOR; HAS BEEN EITHER LICENSED AS A PROFESSIONAL LAND SURVEYOR OR A PROPERTY (2)LINE SURVEYOR OR WAS AUTHORIZED TO PRACTICE LAND SURVEYING OR PROPERTY LINE SURVEYING UNDER §15-303 OF THIS SUBTITLE FOR AT LEAST 25 YEARS, OF WHICH 5 YEARS WERE IN MARYLAND; IS NOT THE SUBJECT OF A PENDING DISCIPLINARY ACTION RELATED (3) TO THE PRACTICE OF LAND SURVEYING OR PROPERTY LINE SURVEYING IN THIS OR ANOTHER STATE: SUBMITS TO THE BOARD AN APPLICATION ON THE FORM PROVIDED BY THE BOARD; (4) AND (5) PAYS TO THE BOARD A FEE, AS SET BY THE BOARD. THE HOLDER OF A RETIRED STATUS LICENSE ISSUED UNDER THIS SECTION MAY NOT (B) (1)ÉNGAGE IN THÉ PRACTICE OF PROFESSIONAL LAND SURVEYING OR PROPERTY LINE SURVEYING. THE HOLDER OF A PROFESSIONAL LAND SURVEYOR RETIRED STATUS LICENSE MAY (2) USE THE DESIGNATION OF "RETIRED PROFESSIONAL LAND SURVEYOR". THE HOLDER OF A PROPERTY LINE SURVEYOR RETIRED STATUS LICENSE MAY USE (3)THE DESIGNATION OF "RETIRED PROPERTY LINE SURVEYOR". THE BOARD MAY REACTIVATE THE LICENSE OF A RETIRED STATUS LICENSE IF THAT INDIVIDUAL: (C) SUBMITS TO THE BOARD AN APPLICATION FOR REACTIVATION ON THE FORM (1)APPROVED BY THE BOARD; (2) MEETS ALL CONTINUING COMPETENCY REQUIREMENTS, NOT EXCEEDING 48 CREDIT HOURS, THAT WOULD HAVE BEEN REQUIRED FOR RENEWAL OF A LICENSE UNDER §15-314 OF THIS SUBTITLE IF THE LICENSEE HAD NOT BEEN PLACED ON RETIRED STATUS; (3) PAYS TO THE BOARD A REACTIVATION FEE AS SET BY THE BOARD; ANDIS NOT THE SUBJECT OF A PENDING DISCIPLINARY ACTION RELATED TO THE PRACTICE OF LAND SURVEYING OR PROPERTY LINE SURVEYING IN THIS OR ANY OTHER STATE.
